● key features

Using AthenaAdvantage you will speedily and accurately:

- produce safety data sheets for any substance or mixture
- calculate the classification of your formulations according to CHIP and CLP/GHS
- design and print supply or transport labels in any format or size
- produce dangerous goods notes, IATA forms and all other consignment documentation.

● data

The software comes with:

- complete classification data from the CLP Annex VI (formerly ASL)
- all EH40 (workplace exposure limits) values for Annex VI substances
- toxicological values
- ADR (Orange Book) Table 1 data for all UN number entries
- IMDG, IATA and CDG data for all UN number entries

● languages

The system is fully multi-lingual covering 24 EU languages.

● live update

The system automatically connects to the internet to download the most recent updates keeping you up to date both legislatively and technically.

● internet/email

● **software upgrades**
